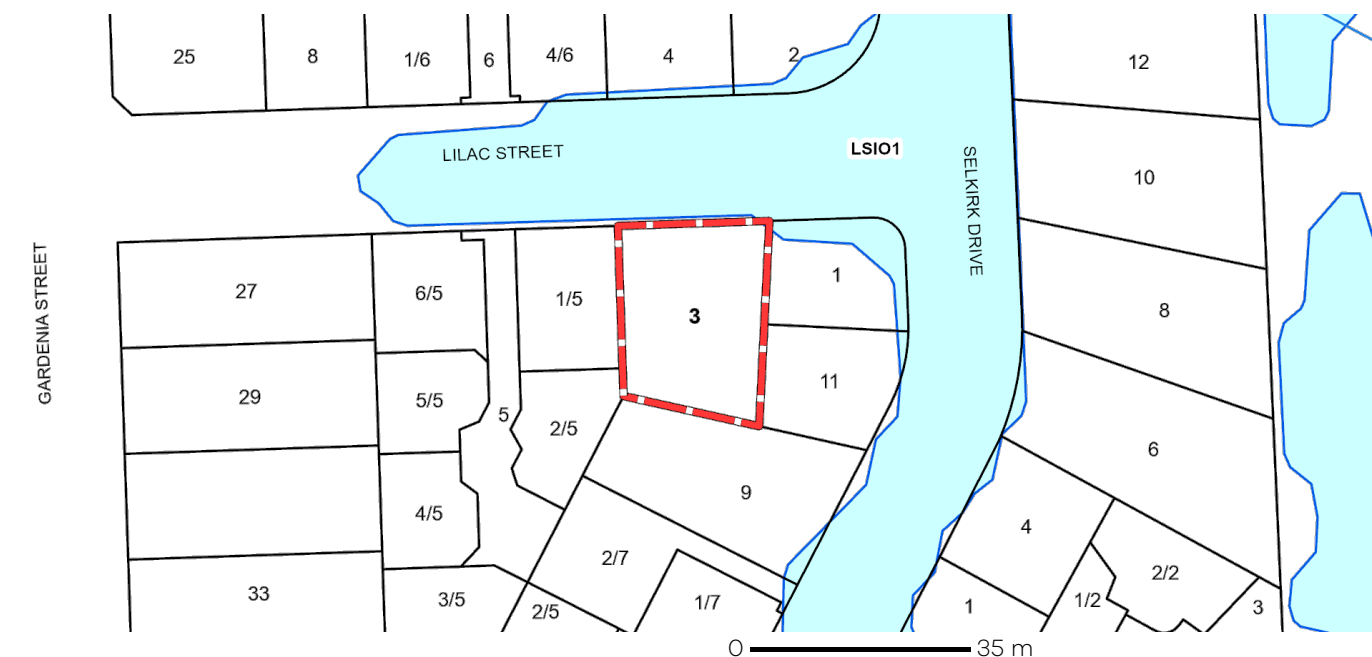


DDO - Design and Development Overlay **Water course**
